On-Site Assessment -

For the short-listed candidates, an on-site assessment will be scheduled to your company to see how you effectively manage your water.

Jury Decision -

Our independent expert panel of five judges from India and Germany will review your submissions and pick a winner.



*Site Visit may be conducted for specific shortlisted companies for ground verification of the information provided in the application. This will be decided on a case-to-case basis as per Jury's discretion.
