To deal with the prevention and control of pollution, and protection of the environment, India has put in place various Acts, Rules, Notifications, Statutory Orders, Ordinances, and Statutes. Apart from these, there are several landmark judgments delivered by the Hon'ble Courts, Tribunal for the protection of the environment. Also, several policies, standards, and guidelines exist for the prevention and control of pollution and the protection of the environment.


There is a lack of a centralized repository of all this information in one place, and which are not easy accessed by public agencies, private agencies, industries, academia, and the public at large.

As a national-level apex body for prevention and control of pollution in the country, the Central Pollution Control Board (CPCB) has taken initiative to bring this information through e-portal (CPCB Legal Information Portal). However, this will be a continual process to make the information as robust and up to date as much as possible.

The CPCB has now brought out an e-portal with all the relevant environmental acts, and rules made thereunder for the benefit of the public agencies, private agencies, industries, academia etc.

The CLIP portal is focused on the five key Environmental Acts:

- The Water (Prevention and Control of Pollution) Act 1974;
- The Air (Prevention and Control of Pollution) Act 1981;
- The Environment (Protection) Act 1986;
- The Public Liability Act 1991; and
- The National Green Tribunal Act 2010




## Key Features of CLIP portal:

- The portal has the Water (Prevention and Control of Pollution) Act, 1974; the Air (Prevention and Control of Pollution) Act, 1981; the Environment (Protection) Act, 1986; the Public Liability Act, 1991; and the National Green Tribunal Act, 2010; as well as of the amendments and rules made thereunder.
- The portal has also some landmark judgments from the Honorable Courts/ Tribunal.
- The portal operates on an open-source Content Management System (CMS) making content management easier for CPCB for regularly updating content.
- The "What's New" tab provides for new information.

CPCB Legal Information Portal is developed by the Central Pollution Control Board with the technical support from the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH under the Project on "Sustainable and Environment-friendly Production, Phase II" commissioned under the ongoing Indo German Development Cooperation by the German Federal Ministry for Economic Cooperation and Development (BMZ).
